## How to use this guide

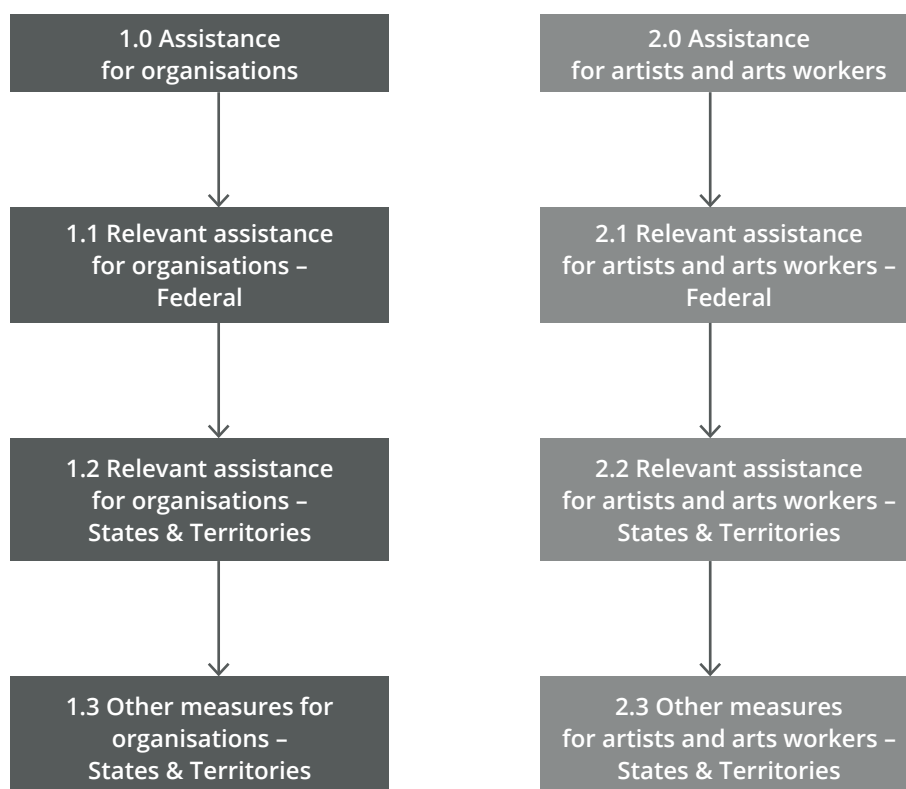
This guide sets out various assistance initiatives that are being provided by Federal and State/Territory governments in response to the COVID-19 pandemic.

# 1.0 Assistance for organisations

## Key points:

- “The boosting cash-flow for employers” initiative is the most applicable to arts organisations. It is easy to access because payments will flow automatically as organisations submit their Business Activity Statements (BAS).
- The Federal Government’s new JobKeeper package will allow arts organisations to continue to pay staff over the next six months.
- Some state and territory governments are gradually releasing support programs. Details (where available) are provided at 1.2 below.
- Other stimulus measures, targeted at small-to-medium enterprises (SMEs), may be applicable, depending on the organisation’s circumstances. Check the list at 1.3 below.

## 1.1 Relevant assistance for organisations – Federal

JobKeeper Payment <span>UPDATED</span>
<b>What is it?</b>
<ul style="list-style-type: none"><li>- A subsidy from the Government to employers to continue paying their employees.</li><li>- Employers will be able to claim a fortnightly payment of \$1,500 per eligible employee from 30 March 2020, for a maximum period of 6 months.</li><li>- Employers will be eligible for the subsidy if their turnover will be reduced by more than 30 per cent relative to a comparable period a year ago (of at least a month). For charities registered with the Australian Charities and Not-For-Profit Commission (ACNC), the reduction in turnover required is 15 per cent.</li><li>- Not-for-profit entities (including charities) and self-employed individuals (businesses without employees) that meet the turnover tests that apply for businesses are eligible to apply for JobKeeper Payments.</li><li>- Eligible employees are employees who:<ul style="list-style-type: none"><li>- are currently employed by the eligible employer (including those stood down or re-hired);</li><li>- were employed by the employer at 1 March 2020;</li><li>- are full-time, part-time, or long-term casuals (a casual employed on a regular basis for longer than 12 months as at 1 March 2020);</li><li>- are at least 16 years of age;</li><li>- are an Australian citizen, the holder of a permanent visa, a Protected Special Category Visa Holder, a non-protected Special Category Visa Holder who has been residing continually in Australia for 10 years or more, or a Special Category (Subclass 444) Visa Holder; and</li><li>- are not in receipt of a JobKeeper Payment from another employer.</li></ul></li></ul>
<b>How does it help?</b>
<p>Provides \$1,500 per person to pay employees with.</p> <ul style="list-style-type: none"><li>- If the employee is earning more than \$1,500 a fortnight, you can:<ul style="list-style-type: none"><li>- Continue to pay them at their current salary level (including super), using the \$1,500 to help meet the costs of this, or</li><li>- You can increase their salary by \$1,500 a fortnight. In this case, you have the option to pay super or not on the additional \$1,500.</li></ul></li><li>- If the employee is earning less than \$1,500 a fortnight then you pay them at least \$1,500 a fortnight. You have the option to pay super or not on the additional amount to raise their salary to \$1,500.</li><li>- If the employee is currently earning nothing (e.g. you let them go earlier in March and have rehired them under this scheme) then you will pay them \$1,500 per fortnight. You have the option to pay super or not this payment.</li><li>- All amounts are before tax (so you will still need to withhold tax from these payments).</li><li>- First payments are due in May, so employers will need to ensure they can cash flow salary payments throughout April.</li></ul>

How do people access it?		
<ul style="list-style-type: none"> <li>– Employers can register their interest in applying for the JobKeeper Payment via <a href="http://ato.gov.au">ato.gov.au</a> from 30 March 2020.</li> <li>– Subsequently, eligible employers will be able to apply for the scheme by means of an online application.</li> <li>– The first payment will be received by employers from the ATO in the first week of May.</li> <li>– Eligible employers will need to identify eligible employees for JobKeeper Payments and must provide monthly updates to the ATO.</li> </ul>

Resilience Fund <span style="background-color: #0070C0; color: white; padding: 2px;">NEW</span>		
What is it?		
The 2020 Resilience Fund is designed to provide emergency relief to support the livelihoods, practice and operations of Australian artists, groups and organisations during the COVID-19 pandemic.		
How does it help?		
Direct funding for individuals and organisations. There are three streams.		
<ul style="list-style-type: none"> <li>– Survive: Small grants for individuals, groups and organisations to offset or recoup money lost due to cancelled activity. Organisations can apply for up to \$5,000.</li> <li>– Adapt: Grants for individuals, groups and organisations to adapt their arts practice and explore new ways of working. Organisations can apply for up to \$20,000.</li> <li>– Create: Grants for individuals, groups and organisations to continue to create artistic work and/or develop creative responses in this time of disruption. Organisations can apply for up to \$20,000.</li> </ul>

Boosting cash flow for employers		
What is it?		
<ul style="list-style-type: none"> <li>– Cash for small-to-medium enterprises and not for profit organisations with annual turnovers of \$50 million or less and have employees.</li> <li>– Organisations will receive an amount equal to 100% of the tax withheld on salaries and wages following lodgement of their March 2020 Business Activity Statement (BAS).</li> <li>– Two additional payments, equal to half of the total initial payment, will be made following the lodgement of their June 2020 and September 2020 BASs.</li> <li>– The timing and amounts of payments differ for organisations which lodge BASs monthly.</li> <li>– Total minimum amount payable across all payments is \$20,000. Total maximum amount payable is \$100,000.</li> </ul>		
How does it help?		
Frees up cash for spending on staff wages and/or other operational costs.		
How do people access it?		
Credits are automatically applied by the ATO through the activity statement system.

Supporting apprentices and trainees		
<b>What is it?</b>		
<ul style="list-style-type: none"> <li>- A wage subsidy of 50% of their apprentice's or trainee's wages paid during the period 1 January 2020 to 30 September 2020.</li> <li>- Where a small business is not able to retain an apprentice, the subsidy will be available to a new employer that employs that apprentice.</li> <li>- Employers will be reimbursed up to a maximum of \$21,000 per eligible apprentice or trainee (\$7,000 per quarter).</li> </ul>		
<b>How does it help?</b>		
Assists organisations with the cost of employing apprentices or trainees.		
<b>How do people access it?</b>		
Employers can register for the subsidy from early April 2020, with an Australian Apprenticeship Support Network (AASN) provider.

Temporary relief for financially distressed businesses		
<b>What is it?</b>		
<ul style="list-style-type: none"> <li>- A range of initiatives to ease pressure on businesses in financial distress.</li> <li>- The most relevant for arts organisations is that directors (in this case, board members) will be temporarily relieved of their duty to prevent insolvent trading for six months.</li> <li>- Other initiatives include allowing more time for businesses to respond to demands from creditors and temporary flexibility in the Corporations Act 2001 to provide targeted relief for companies from provisions of the Act to deal with unforeseen events.</li> </ul>		
<b>How does it help?</b>		
The temporary change in directors' responsibilities relieves directors of personal liability that would otherwise be associated with the insolvent trading.		
It will assist board members in decision making to help organisations trade through the crisis with the aim of returning to viability when the crisis has passed.		
<b>How do people access it?</b>

Small Business Support Fund <span style="color: #0070C0;">NEW</span>		
<b>What is it?</b>		
<p>\$10,000 grants for small businesses impacted by restrictions on public gathering and movement.</p> <p>To be eligible, businesses will need to:</p> <ul style="list-style-type: none"> <li>- have between 1-19 employees and a turnover of more than \$75,000</li> <li>- a payroll below the NSW Government 2019-20 payroll tax threshold of \$900,000</li> <li>- have an Australian Business Number as at 1 March 2020, be based in NSW and employ staff as at 1 March 2020</li> <li>- be highly impacted by the Public Health (COVID-19 Restrictions on Gathering and Movement) Order 2020 issued on 30 March 2020</li> <li>- use the funding for unavoidable business costs such as utilities, overheads, legal costs and financial advice</li> <li>- provide appropriate documentation upon application.</li> </ul>

<b>What is it?</b>		
<p>This \$2 million grant program will allow businesses to:</p> <ul style="list-style-type: none"> <li>- modify their operating model to produce income and supply products</li> <li>- develop online and e-commerce capabilities</li> <li>- do training and professional development to better prepare for return to business activities</li> <li>- invest in capital works to help the business benefit from the economic recovery.</li> </ul>		
<b>How does it help?</b>		
Direct funding for operational and business capabilities. Applications close on 27 April 2020.

### Cultural sector resilience grants (City of Sydney) NEW

#### What is it?

This grant is intended to help not-for-profit arts enterprises and sole traders. To be eligible you will need to demonstrate :

- you employ less than 20 full-time equivalent employees, not including artists employed on a casual basis
- a significant loss of revenue
- a turnover of less than \$10 million
- you're located within our area or serve our local community
- how existing support from other levels of government is inadequate
- how you plan to adapt your operations to the restricted trading environment.

#### How does it help?

Direct funding to assist with staff wages, wages for freelance or casual workers who have lost work, administrative costs, training and professional development.

### Creative fellowships fund (City of Sydney) NEW

#### What is it?

This grant will help individuals and collectives develop new projects during the pandemic. To be eligible you will need to demonstrate:

- a significant loss of revenue
- you're an individual, sole trader or a group auspiced by a cultural organisation
- networks and professional experience within local cultural and creative sectors
- you can develop new projects and work with community and cultural organisations
- how you'll develop and share your project within 6 months of receiving funds.

Direct funding to assist with projects: materials and equipment, your time, fees for people working with you, training and professional development.

A \$10,000 grant for Small businesses and not-for-profit entities that employ South Australians who have been highly impacted by the COVID-19.		
To be eligible, businesses and not-for-profits including eligible sporting and community organisations will need to:		
Employ people in South Australia.		
<ul style="list-style-type: none"> <li>- Have annual turnover of more than \$75,000 (GST exclusive).</li> <li>- Have an annual payroll of less than \$1.5 million, and not be entitled to a payroll tax waiver under COVID-19 support measures introduced by the South Australian Government.</li> <li>- Have an ABN and were carrying on the operation of the business in South Australia on 1 March 2020.</li> <li>- Have been subject to closure or highly impacted by COVID-19 related restrictions.</li> <li>- Apply by 1 June 2020.</li> <li>- Use the funds to support activities related to the operation of the business.</li> </ul>		
If:		
The business has received any South Australian Government grants provided to address COVID-19 related business impacts, the value of these payment(s) will be deducted from the \$10,000 grant.		
The business is part of a group of companies that is registered for payroll tax and will receive the payroll tax waiver, the business is ineligible for this grant.

<b>What is it?</b>		
<p>\$10,000 grants to support small businesses that employ staff and are subject to closure or highly impacted by shutdown restrictions.</p> <p>To be eligible, businesses will need to</p> <ul style="list-style-type: none"> <li>- Have been subject to closure or highly impacted by shutdown restrictions announced by the Victorian Government; and</li> <li>- Employ people; and</li> <li>- Have a turnover of more than \$75,000; and</li> <li>- Have a payroll of less than \$650,000; and</li> <li>- Hold an Australian Business Number (ABN) and have held that ABN at 16 March 2020 (date of the State of Emergency declaration); and</li> <li>- Have been engaged in carrying out the operation of the business in the Australian State of Victoria on 16 March 2020.</li> </ul>		
<b>How does it help?</b>

<b>What is it?</b>		
Grants of \$2,500 as one off emergency support payments.		
Applicants must:		
<ul style="list-style-type: none"> <li>- Employ fewer than 20 full time equivalent (FTEs) employees (casual or part-time), on or before 31 January 2020, or: <ul style="list-style-type: none"> <li>- a sole trader</li> <li>- non-employing business</li> <li>- owner operator.</li> </ul> </li> <li>- Have been operating their business (not a hobby or charity) on or before 31 January 2020.</li> <li>- Be registered for tax purposes in Australia with an Australian Business Number (ABN).</li> <li>- Be a majority owned and operated Tasmanian business in one of the following severely impacted industries: <ul style="list-style-type: none"> <li>- Seafood</li> <li>- Tourism and accommodation</li> <li>- Retail</li> <li>- Hospitality</li> <li>- Arts and entertainment</li> <li>- Fitness</li> </ul> </li> </ul>		
Plus		
<ul style="list-style-type: none"> <li>- suppliers to the above sectors (who derive the majority of their income from the above sectors), and</li> <li>- exporters (any business who in 2018-19 derived the majority of the income from international exports).</li> </ul>		
Note:		
<ul style="list-style-type: none"> <li>- A second \$20 million round of \$15 000 grants will be made available for small businesses in the identified sectors that are experiencing severe financial hardship. Businesses seeking this large grant should first apply for the Small Business Emergency Support Grant.</li> <li>- Details of the \$15 000 Small Business Financial Hardship Grant will be announced in due course along with the application process.</li> </ul>

Additional arts organisations funding and operational measures		
What is it?		
<ul style="list-style-type: none"> <li>– Organisations currently on a single year funding package or those in the final year of agreements under the Arts Tasmania Organisations Program will have these contracts extended for another year.</li> <li>– Additional competitive funding will also be made available for arts organisations that will support additional employment and cultural activity. This will be open to organisations based in Tasmania that are not already receiving support through Arts Tasmania's Organisations (multi-year), Cultural Heritage Organisations, Cultural Heritage Organisations (multi-year) or those in receipt of annual funding extension. (Organisations in receipt of administered funding from the Tasmanian Government (including the Theatre Royal Management Board) are not eligible to apply for support package funds)</li> <li>– As part of Arts Tasmania contracts with funded clients, 10 per cent of funds are withheld until acquittals have been received, processed and accepted. This 10 per cent will now be released early.</li> <li>– Temporary suspension of repayment of current low-interest loans and loans made under the COLLECT Art Purchase Scheme.</li> </ul>

Event Cancellation Relief for Arts, Sports and Community Groups <span style="color: #0070C0;">NEW</span>		
<b>What is it?</b>		
<ul style="list-style-type: none"> <li>- Support will be available for not-for-profit arts, sports and community organisations that are experiencing financial hardship as a result of a cancelled event resulting from COVID-19.</li> <li>- This program will consider cancellation costs, loss of revenue and incurred and/or committed costs related to events that delivered broad community benefit.</li> <li>- Lotterywest will be working directly with sports, arts and community groups to deliver this program in collaboration with the Department of Local Government, Sports and Cultural Industries and Venueswest.</li> </ul>		
<b>How does it help?</b>

## 2.0 Assistance for individual artists and arts workers

### Key points:

- The Federal Government's JobKeeper program should provide financial support to many individual artists and arts workers. However, many questions about eligibility in specific circumstances, particularly for casual workers remain.
- Artists and arts workers have increased access to income support. See 2.1 below.
- Income support payments have been boosted and two additional \$750 payments are also available.
- Some state and territory governments have additional and/or extended grant opportunities for individual artists. See 2.2 below.

### 2.1 Relevant assistance for individual artists and arts workers – Federal

JobKeeper Payment <span>UPDATED</span>
<b>What is it?</b>
<ul style="list-style-type: none"><li>- A subsidy from the Government to employers to continue paying their employees.</li><li>- Employers will be able to claim a fortnightly payment of \$1,500 per eligible employee from 30 March 2020, for a maximum period of 6 months.</li><li>- Employers will be eligible for the subsidy if their turnover will be reduced by more than 30 per cent relative to a comparable period a year ago (of at least a month). For charities registered with the Australian Charities and Not-For-Profit Commission (ACNC), the reduction in turnover required is 15 per cent.</li><li>- Not-for-profit entities (including charities) and self-employed individuals (businesses without employees) that meet the turnover tests that apply for businesses are eligible to apply for JobKeeper Payments.</li><li>- Eligible employees are employees who:<ul style="list-style-type: none"><li>- are currently employed by the eligible employer (including those stood down or re-hired);</li><li>- were employed by the employer at 1 March 2020;</li><li>- are full-time, part-time, or long-term casuals (a casual employed on a regular basis for longer than 12 months as at 1 March 2020);</li><li>- are at least 16 years of age;</li><li>- are an Australian citizen, the holder of a permanent visa, a Protected Special Category Visa Holder, a non-protected Special Category Visa Holder who has been residing continually in Australia for 10 years or more, or a Special Category (Subclass 444) Visa Holder; and</li><li>- are not in receipt of a JobKeeper Payment from another employer.</li></ul></li></ul>
<b>How does it help?</b>
<p>Provides \$1,500 per person to pay employees with.</p> <ul style="list-style-type: none"><li>- If the employee is earning more than \$1,500 a fortnight, you can:<ul style="list-style-type: none"><li>- Continue to pay them at their current salary level (including super), using the \$1,500 to help meet the costs of this, or</li><li>- You can increase their salary by \$1,500 a fortnight. In this case, you have the option to pay super or not on the additional \$1,500.</li></ul></li><li>- If the employee is earning less than \$1,500 a fortnight then you pay them at least \$1,500 a fortnight. You have the option to pay super or not on the additional amount to raise their salary to \$1,500.</li><li>- If the employee is currently earning nothing (e.g. you let them go earlier in March and have rehired them under this scheme) then you will pay them \$1,500 per fortnight. You have the option to pay super or not this payment.</li><li>- All amounts are before tax (so you will still need to withhold tax from these payments).</li></ul>

How do people access it?		
<ul style="list-style-type: none"> <li>- Individuals don't need to do anything; the onus is on the employer to register for the scheme.</li> <li>- However, individuals can talk to their employer about their plans for registering for the scheme.</li> <li>- Individuals with multiple employers will need to nominate a "primary employer" from which they will receive the payment. (You can't get it from more than one employer).</li> <li>- Many questions remain about the treatment of casual employees. These employees should talk to their employer about their plans for registering for the scheme and also await further details.</li> <li>- If individuals do not qualify for the JobKeeper payment, they should consider applying for the JobSeeker payment from Centrelink.</li> </ul>

## Income Support for Individuals

### What is it?

- The temporary expansion of eligibility to income support payments and the establishment of a new, time-limited COVID-19 supplement of \$550 per fortnight.
- Payable to people on
  - Jobseeker Payment (and all payments progressively transitioning to JobSeeker Payment; those currently receiving Partner Allowance, Widow Allowance, Sickness Allowance and Wife Pension)
  - Youth Allowance for job seekers
  - Youth Allowance for students
  - Austudy for students
  - ABSTUDY for students
  - Parenting Payment
  - Farm Household Allowance
  - Special Benefit
- Expanded access: Jobseeker Payment and Youth Allowance Jobseeker criteria will provide payment access for permanent employees who are stood down or lose their employment. The expanded eligibility applies to:
  - sole traders
  - the self-employed
  - casual workers
  - contract workers who meet the income tests as a result of the economic downturn due to the COVID-19. This could also include a person required to care for someone who is affected by the COVID-19.
- Reduced means testing.
- Reduced waiting times.

Direct income for artists and arts workers who have lost their income streams. Expanded eligibility is particularly applicable to sole traders, self-employed and contract workers in the arts.
